LIMITATION OF PARTNERSHIP LIABILITY

Notwithstanding anything to the contrary contained herein or in any other membership plan documents, in the event any member, guest or any other person obtains a judgement, claim, or settlement from the Club, whether based upon contractual liability, tort liability, or otherwise, then such judgement, claim or settlement shall be satisfied from, and limited to, the golf facilities of the Club. In no event shall such judgement, claim, or settlement extend to Tillman Development Corporation, its directors, officers, employees, affiliates, representatives or agents.
